

At the regular meeting of the Shiawassee County Board of Commissioners held on Thursday, December 13, 2018 in the Commissioner Chambers, Surbeck Building, Corunna, Michigan:

The meeting was called to order by Chairman Bartz at 5:00 p.m.

Pledge of Allegiance was recited.

Invocation was offered by Vice-Chairman Marks.

It was moved by Commissioner Bruff, seconded by Commissioner Root to approve the minutes of the November 8, 2018, Board of Commissioners meeting. Motion carried.

It was moved by Commissioner Root, seconded by Commissioner Holzhausen to set a Public Hearing on the 2019 Shiawassee County Proposed General Fund Budget for 6:00p.m. on Thursday, December 20, 2018, to be followed immediately by a Special Board Meeting to establish the 2019 tax millage rate and approve the 2019 County Budget. Motion carried.

It was moved by Commissioner Root, seconded by Commissioner Holzhausen to authorize the annual Agreement for Extension Services with Michigan State University funded by voter approved millage assessment, and authorize the Board Chair to execute all necessary documents. Motion carried.

It was moved by Commissioner Root, seconded by Commissioner Marks to authorize the Register of Deeds to proceed with a preservation and digitization project on recorded Plats with Kofile Technologies in the amount of \$94,937.50 to be paid from the Register of Deeds Automation Fund #256-268-970.000 and authorize the Board Chair to execute all necessary documents. Motion carried with the following roll call vote of 7 yeas: Commissioners Root, McMaster, Coscarelli, Bruff, Marks, Holzhausen and Chairman Bartz. 0 nays.

It was moved by Commissioner Root, seconded by Commissioner Holzhausen to authorize the Sheriff's Office to purchase one 2019 Police Charger AWD car from Slingerland Chrysler in the amount of \$25,407 with \$20,000 to be paid from account #101-333-718.000 and \$5,407 to be paid from account #101-333-860.000. Motion carried with the following roll call vote of 7 yeas: Commissioners McMaster, Coscarelli, Bruff, Marks, Holzhausen, Root and Chairman Bartz. 0 nays.

It was moved by Commissioner Root, seconded by Commissioner Marks to approve a 2-year contract for shared technology support services with the Shiawassee Regional Education Service District (SRESA) and the Shiawassee County Sheriff's Office at a cost of \$75,000 per year to replace the current contract with NetSource One, and authorize the Sheriff to sign all necessary documents. Motion carried with the following roll call vote of 7 yeas: Commissioners Coscarelli, Bruff, Marks, Holzhausen, Root, McMaster and Chairman Bartz. 0 nays.

It was moved by Commissioner Root, seconded by Commissioner Marks to approve a 3-year contract with Zix to provide services to the County for secure email archiving, email spam filtering, and email encryption at an annual cost of \$8,331.50 to replace the current contract with Barracuda and to be paid from account #258-970.000. Motion carried with the following roll call vote of 7 yeas: Commissioners Bruff, Marks, Holzhausen, Root, McMaster, Coscarelli and Chairman Bartz. 7 nays.

It was moved by Commissioner Root, seconded by Commissioner Bruff to approve the minutes of December 10, 2018, Finance and Administration Committee meeting. Motion carried.

It was moved by Commissioner Coscarelli, seconded by Commissioner Bruff to approve the contract between the Michigan Department of Health and Human Services (DHHS) and the Prosecutor's Office for the provision of legal services to DHHS; the contract to provide \$50,000 per year from December 2018 through September 2021 with option for two additional one-year periods; the Prosecutor to execute all necessary documents. Motion carried with the following roll call vote of 7

yeas: Commissioners Marks, Holzhausen, Root, McMaster, Coscarelli, Bruff and Chairman Bartz. 0 nays.

It was moved by Commissioner Coscarelli, seconded by Commissioner Bruff to authorize the renewal contract between Catholic Charities of Shiawassee and Genesee County to provide housing at 1042 N. Shiawassee Street and/or 201 E. McArthur Street, Corunna, MI at a rate of \$33 per day for Base Housing from 10/01/18 to 09/30/19 and authorize the Board Chair to execute all necessary documents. Motion carried with the following roll call vote of 7 yeas: Commissioners Holzhausen, Root, McMaster, Coscarelli, Bruff, Marks and Chairman Bartz. 0 nays.

It was moved by Commissioner Coscarelli, seconded by Commissioner Holzhausen to authorize the County Coordinator to execute the revised Michigan Indigent Defense Commission (MIDC) Compliance Plan contract and authorize the Public Defender in consultation with the Coordinator to execute other necessary documents, continue hiring staff, and authorizing expenditures in accordance with, and in amounts not to exceed the funding provided by, the MIDC Compliance Plan and contract. Motion carried with the following roll call vote of 5 yeas: Commissioners Root, Coscarelli, Bruff, Holzhausen and Chairman Bartz. 2 nays: Commissioners McMaster and Marks.

It was moved by Commissioner Coscarelli, seconded by Commissioner Holzhausen to approve the minutes of the December 11, 2018, Public Safety and Courts Committee meeting. Motion carried.

It was moved by Commissioner Root, seconded by Commissioner Marks to approve the Mid-State Health Network 2019 Substance Use Disorder (SUD) Oversight Policy Advisory Board Intergovernmental Agreement and authorize the Board Chair to execute all necessary documents. Motion carried with the following roll call vote of 7 yeas: Commissioners McMaster, Coscarelli, Bruff, Marks, Holzhausen, Root and Chairman Bartz. 0 nays.

It was moved by Commissioner Root, seconded by Commissioner Marks to authorize the Health Department to hire an International Board Certified Lactation Consultant, Salary Grade 7, \$18.11 - \$23.54 per hour, to fill a vacancy. Motion carried with the following roll call vote of 7 yeas: Commissioners Coscarelli, Bruff, Marks, Holzhausen, Root, McMaster and Chairman Bartz. 0 nays.

It was moved by Commissioner Root, seconded by Commissioner Bruff to approve the minutes of the December 11, 2018, Health and Human Services Committee meeting. Motion carried.

Commissioner McMaster inquired as to increasing Clerk Vital Record fees? Will be discussed at December 20, 2018 budget meeting.

Commissioner Marks inquired as to the error in the Register of Deeds budget? Commissioner Root reassured the money will be put back in.
