

At the regular meeting of the Shiawassee County Board of Commissioners held on Thursday, January 16, 2020, in the Commissioner Chambers, Surbeck Building, Corunna, Michigan:

The meeting was called to order by Chairman Root at 5:00 p.m.

Pledge of Allegiance was recited.

Invocation was offered by Vice-Chairman Marks.

Roll Call found Commissioners: Webster, Holzhausen, McMaster, Garber, Marks, Plowman, and Chairman Root present.

It was moved by Commissioner Plowman, seconded by Commissioner Webster to approve the Agenda with the amendment of adding a Consent Agenda from Economic and Physical Development items B,C,D and E. Motion carried.

It was moved by Commissioner Garber, seconded by Commissioner Marks to approve the minutes of the December 12, 2019, Board of Commissioners meeting. Motion carried.

It was moved by Commissioner Plowman, seconded by Commissioner Garber to approve the minutes of the January 2, 2020, Organizational meeting. Motion carried.
