

At the regular meeting of the Shiawassee County Board of Commissioners held on Thursday, July 14, 2022 in the Commissioner Chambers, Surbeck Building, Corunna, Michigan:

The meeting was called to order by Chairman Brodeur at 5:00 p.m.

Pledge of Allegiance was recited.

Invocation was offered by Commissioner Webster.

Roll call found Commissioners Webster, Holzhausen, Howard, Garber, Marks, Plowman and Chairman Brodeur present.

It was moved by Commissioner Marks, seconded by Commissioner Plowman to approve the agenda as presented. Motion carried.

It was moved by Commissioner Plowman, seconded by Commissioner Marks to approve the minutes of the June 16, 2022 Board of Commissioners meeting. Motion carried.

It was moved by Commissioner Plowman, seconded by Commissioner Marks to approve the bills listed on the Invoice Edit Reports dated June 14, 2022, Invoice Edit Report dated June 17, 2022, Invoice Edit Report dated June 23, 2022, Invoice Edit Report dated June 24, 2022, Invoice Edit Report dated June 30, 2022, Invoice Edit Report dated July 1, 2022.
