

At the regular meeting of the Shiawassee County Board of Commissioners held on Thursday, January 12, 2023 in the Commissioner Chambers, Surbeck Building, Corunna, Michigan:

The meeting was called to order by Chairman Brodeur at 5:00 p.m.

Pledge of Allegiance was recited.

Invocation was offered by Commissioner Webster.

Roll call found Commissioners Webster, Holzhausen, Garber, Howard, Emery and Chairman Brodeur present. Commissioners Holzhausen and Johnson excused.

It was moved by Commissioner Garber, seconded by Commissioner Howard to approve the agenda as presented. Motion carried.

It was moved by Commissioner Garber, seconded by Commissioner Webster to approve the minutes of the December 15, 2022 Board of Commissioners meeting. Motion carried.

It was moved by Commissioner Garber, seconded by Commissioner Webster to approve the minutes of the January 4, 2023, Organizational meeting. Motion carried.

It was moved by Commissioner Garber, seconded by Commissioner Emery to approve the contract as presented with Memorial Healthcare and authorize the chair to execute the same. It was moved by Commissioner Garber, seconded by Commissioner Howard to approve the annual renewal with ZixArchive in an amount not exceed \$9,350. Motion carried with the following roll call vote of 5 yeas: Commissioners Garber, Howard, Emery, Webster and Chairman Brodeur. 0 nays.

It was moved by Commissioner Garber, seconded by Commissioner Howard to approve the minutes of the January 10, 2023, Finance and Administration Committee meeting. Motion carried.

It was moved by Commissioner Webster, seconded by Commissioner Emery to approve the yearly maintenance contract with INdigital at a yearly cost of \$24,264.94 from account 216-325-801.000, and authorize the chair to execute the same. Motion carried with the following roll call vote of 5 yeas: Commissioners Garber, Howard, Emery, Webster and Chairman Brodeur. 0 nays.

It was moved by Commissioner Webster, seconded by Commissioner Garber to approve the purchase of servers from CDW-G in an amount not to exceed \$53,500.00 from 216-325-970.000, and authorize the chair to execute the same. Motion carried with the following roll call vote of 5 yeas: Commissioners Howard, Emery, Webster, Garber and Chairman Brodeur. 0 nays.

It was moved by Commissioner Webster, seconded by Commissioner Emery to approve the purchase of a new 2023 Chevrolet Tahoe police responder in a total amount of \$54,514.45. Motion carried with the following roll call vote of 5 yeas: Commissioners Emery, Webster, Garber, Howard and Chairman Brodeur. 0 nays.

It was moved by Commissioner Webster, seconded by Commissioner Howard to approve the minutes of the January 10, 2023, Public Safety and Courts Committee meeting. Motion carried.
