WHEREAS, at the October 7, 2021 meeting, by a vote of 5 to 0 an apportionment plan was adopted;

NOW, THEREFORE, BE IT RESOLVED, that the Shiawassee County Apportionment Commission does hereby adopt the attached map and boundary description as the Apportionment Plan for the Shiawassee County Board of Commissioners commencing with the Commissioner terms beginning January 1, 2022.
