Call to order: 5:00 p.m.

All Commissioners present: Chairman Marks, Commissioners Howard, Garber, Plowman, Brodeur, Webster and Holzhausen.

The Pledge of Allegiance was recited.

It was moved by Commissioner Webster, seconded by Commissioner Brodeur to approve the agenda as presented.

Tony Newman, Drain Commissioner and Jamie Burkton from HRC gave presentation on storm water project planning.

Call to the Public: Phil Hathaway, Gary Burke and Kevin Smith gave presentation on Shiatown Dam Removal Project.
Tom Manke, Owosso – Update on the land opportunity meeting in Durand/Vernon.

It was moved by Commissioner Plowman, seconded by Commissioner Brodeur to move to Thursday's Board of Commissioner's meeting for consideration to approve resolution 22-04-08 amending and restating the comprehensive financial plan. Motion carried.

It was moved by Commissioner Plowman, seconded by Commissioner Garber to move to Thursday's Board of Commissioner's meeting for consideration to accept and place on file the 2021 county clerk's year-end report. Motion carried.

Motion carried.

It was moved by Commissioner Webster, seconded by Commissioner Howard to move to Thursday's Board of Commissioner's meeting for consideration to approve the contract renewal with Combined Public Communications for inmate phone and visitation, and authorize the Chair to execute the same. Motion carried.

It was moved by Commissioner Webster, seconded by Commissioner Howard to move to Thursday's Board of Commissioner's meeting for consideration to approve the contract between Shiawassee County Health and Wellness and Shiawassee County for Juvenile services and authorize the Chair to execute the same. Motion carried.

It was moved by Commissioner Webster, supported by Commissioner Plowman to move to the next Committee of the Whole for consideration to replace the jail camera server system in an amount not to exceed \$22,445.33. Motion carried

It was moved by Commissioner Garber, seconded by Chairman Brodeur to move to Thursday's Board of Commissioner's meeting for consideration to waive the attorney-client privilege and make the April 5, 2022 privileged letter between Cohl, Stoker & Toskey, P.C. and Michael Reeve available to the public. Further moved that the County intends this waiver to be limited to the described letter and that letter only. Motion carried.

It was moved by Commissioner Garber, seconded by Commissioner Holzhausen to move to Thursday's Board of Commissioner's meeting for consideration to instruct Corporate Counsel to draft and place on the ballot with the Shiawassee County Clerk a millage for the August Primary for Senior Services at .50 mills. Motion carried.

It was moved by Commissioner Garber, seconded by Commissioner Plowman to move to Thursday's Board of Commissioner's meeting for consideration to approve resolution 22-04-07 commemorating the completion of the Siatown Dam Removal, Site Reforestation, Park Rededication, and approve the access agreement. Motion carried.

It was moved by Commissioner Garber, supported by Commissioner Plowman to move to the next Committee of the Whole meeting for consideration to appoint Dr. Michael Markey as the Medical Examiner for Shiawassee County and Dr. Christopher Hauch as the Deputy Medical Examiner of record. Motion carried.
