

At the regular meeting of the Shiawassee County Board of Commissioners held on Wednesday, October 18, 2023 in the Commissioner Chambers, Surbeck Building, Corunna, Michigan:

The meeting was called to order by Chairman Brodeur at 5:00 p.m.

Pledge of Allegiance was recited.

Invocation was offered by Commissioner Emery.

Roll call found Commissioners Holzhausen, Garber, Howard, Emery and Chairman Brodeur present. Commissioners Webster and Johnson were excused.

It was moved by Commissioner Garber, seconded by Commissioner Howard to approve the agenda as presented. Motion carried.

It was moved by Commissioner Emery, seconded by Commissioner Garber to approve the minutes of the September 13, 2023 Board of Commissioners meeting. Motion carried.

It was moved by Commissioner Garber, seconded by Commissioner Howard to approve the bills listed on the Invoice Edit Reports dated September 15, 2023, Invoice Edit Reports dated September 22, 2023, Invoice Edit Reports dated September 28, 2023, Invoice Edit Reports dated September 29, 2023, Invoice Edit Reports dated October 4, 2023, Invoice Edit Reports dated October 5, 2023, Invoice Edit Reports dated October 10, 2023 and Invoice Edit Reports dated October 13, 2023. At a regular meeting of the Shiawassee County Board of Commissioners held at 5:00 P.M. on October 18, 2023, in the Commissioner’s Chambers located on the 1st Floor of the Surbeck Building, 201 N Shiawassee St., Corunna, Michigan, at which time the following members were present:

Commissioner _____ moved, supported by Commissioner _____, to adopt the following to amend the Shiawassee County Zoning Ordinance.

PREAMBLE: The Shiawassee County Zoning Ordinance (“Ordinance”) as adopted by the Board of Commissioners of the County of Shiawassee, pursuant to Public Act 183 of 1943 (as amended and replaced by Public Act 110 of 2006, as also amended), may be amended following the procedures outlined in said Ordinance and in compliance with Public Act 110 of 2006, as amended.

WHEREAS: REX7204, LLC, PO Box 178, New Lothrop, MI, filed a petition to amend the Zoning Map designation for certain parcels from A-2, General Agricultural Production/ Rural Residential to B-2, General Business said parcels of land being located in Section 14 of Middlebury Township (Parcel Ids.# 78-005-14-400-001 & 78-005-14-400-004) and legally described as follows:

THEREFORE BE IT RESOLVED: The Shiawassee County Board of Commissioners, having considered the recommendation and findings of the Shiawassee County Planning Commission and having reviewed the request of the applicant, ordains to amend the official Zoning Map (Article 2, Section 2.1.2) of the Ordinance by changing the zoning designation of the above referenced property from A-2, General Agricultural Production/ Rural Residential to B-2, General Business.

period of 10/1/23 through 9/30/24 and authorize the board chair to execute the contract. Motion carried with the following roll call vote of 5 yeas: Commissioners Garber, Howard, Emery, Holzhausen and Chairman Brodeur. 0 nays.

It was moved by Commissioner Garber, seconded by Commissioner Holzhausen to approve the grant agreement between the Michigan Department of Health and Human Services and the Shiawassee County Health Department for Public Health Services - Emerging Threats in the amount of \$1,611,718 for a period of 10/1/23 through 9/30/24 and authorize the board chair to execute the contract. Motion carried with the following roll call vote of 5 yeas: Commissioners Garber, Howard, Emery, Holzhausen and Chairman Brodeur. 0 nays.

It was moved by Commissioner Garber, seconded by Commissioner Howard to approve the minutes from the October 17, 2023 Health and Human Services Committee meeting. Motion carried.
