It was moved by Commissioner Emery, supported by Commissioner Howard to move to the Wednesday Board of Commissioners meeting for consideration to approve the replacement of two correctional deputies not to exceed Step 3.

It was moved by Commissioner Emery, supported by Commissioner Howard to move to the Wednesday Board of Commissioners meeting for consideration to approve the contract with Michigan Mental Health Court for a grant in the amount of \$82,705, the Edward Byrne Memorial Justice Assistance Grant in the amount of \$79,000, the Michigan Drug Court Grant Program in the amount of \$54,000, and the Swift and Sure Sanctions Probation Program Grant in the amount of \$55,000, and authorize the board chair to execute all necessary documents. Motion carried.

It was moved by Commissioner Howard, supported by Commissioner Emery to move to the Wednesday Board of Commissioners meeting for consideration to approve the appointment of Krissi Lab and Alyson Caverson as non-attorney district court magistrates as requested by the chief judge. Motion carried.

It was moved by Commissioner Howard, supported by Commissioner Emery to move to the Wednesday Board of Commissioners meeting for consideration to approve the purchase two golf carts from Carts R Us in an amount not to exceed \$15,100 from the fund 260-301-970.000. Motion carried.

It was moved by Commissioner Emery, supported by Commissioner Howard to move to the Wednesday Board of Commissioners meeting for consideration to approve the contract as presented from LACASA in an amount not to exceed \$54,040 to be paid for from the Child Care Fund, and authorize the board chair to execute the agreement. Motion carried.
