

At the meeting of the Shiawassee County Board of Commissioners held on Wednesday, November 20, 2024 in the Commissioner Chambers, Surbeck Building, Corunna, Michigan:

The meeting was called to order by Chairman Brodeur at 5:00 p.m.

Pledge of Allegiance was recited.

Invocation was offered by Commissioner Webster.

Roll call found Commissioners Webster, Holzhausen, Johnson, Garber, Howard, Emery and Chairman Brodeur present.

It was moved by Commissioner Howard, seconded by Commissioner Garber to approve the agenda as presented. Motion carried.

It was moved by Commissioner Webster, seconded by Commissioner Howard to approve the minutes of the October 23, 2024 Board of Commissioners meeting. Motion carried.

It was moved by Commissioner Garber, seconded by Commissioner Howard to approve the bills listed on the Invoice Edit Reports dated October 23, 2024, Invoice Edit Reports dated October 24, 2024, Invoice Edit Reports dated October 25, 2024, Invoice Edit Reports dated November 1, 2024, Invoice Edit Reports dated November 7, 2024, Invoice Edit Reports dated November 8, 2024, and Invoice Edit Reports dated November 15, 2024. It was moved by Commissioner Garber, seconded by Commissioner Howard to accept the tentative wage re-opener agreement between AFSCME and Shiawassee County for FY 2025 and authorize the chair to execute the final agreement. Motion carried with the following roll call vote of 7 yeas: Commissioners Webster, Holzhausen, Johnson, Garber, Howard, Emery and Chairman Brodeur. 0 nays.

It was moved by Commissioner Garber, seconded by Commissioner Howard to approve the minutes from the November 18, 2024 Finance and Administration Committee meeting. Motion carried. It was moved by Commissioner Webster, seconded by Commissioner Garber to approve the contract with the SRES and the County for services to the Sheriff's Department. Motion carried with the following roll call vote of 7 yeas: Commissioners Garber, Howard, Emery, Webster, Holzhausen, Johnson and Chairman Brodeur. 0 nays.

It was moved by Commissioner Webster, seconded by Commissioner Howard to approve the minutes from the November 19, 2024 Public Safety and Courts Committee meeting. Motion carried.

It was moved by Commissioner Garber, seconded by Commissioner Emery to approve the MSU Extension Services for 2025 and authorize the Board Chairman to sign the agreement. Motion carried with the following roll call vote of 7 yeas: Commissioners Garber, Howard, Emery, Webster, Holzhausen, Johnson and Chairman Brodeur. 0 nays.

It was moved by Commissioner Garber, seconded by Commissioner Holzhausen to approve the chairman's selection of Ben Frederick to Shiawassee Health and Wellness. Motion carried.

It was moved by Commissioner Garber, seconded by Commissioner Emery to approve the minutes from the November 19, 2024 Health and Human Services Committee meeting. Motion carried.

Chairman Brodeur chose to decline to report on anything this month.

County Coordinator Dr. Boggs reported on important upcoming dates and events.
