APPROVING A BROWNFIELD PLAN
FOR THE LENNON ROAD REDEVELOPMENT, LENNON, MICHIGAN, PURSUANT TO AND
IN ACCORDANCE WITH THE PROVISIONS OF ACT 381 OF THE
PUBLIC ACTS OF THE STATE OF MICHIGAN OF 1996, AS AMENDED**

At a regular meeting of the Shiawassee County Board of Commissioners, held in the Surbeck Building, 201 North Shiawassee Street, 1st Floor, Corunna, Michigan, 48817 on the 16th day of July 2025 at 5:00 PM.

WHEREAS, the Michigan Brownfield Redevelopment Financing Act, Act 381, P.A. 1996 as amended ("Act 381"), authorizes municipalities to create a brownfield redevelopment authority to

promote the revitalization, redevelopment, and reuse of contaminated, blighted, functionally obsolete, historically designated, or housing property through tax increment financing of eligible activities approved in a Brownfield Plan; and

WHEREAS, the Shiawassee County Board of Commissioners established the City of Shiawassee County Brownfield Redevelopment Authority, under the procedures in Act 381, to facilitate the redevelopment of Brownfields within the County of Shiawassee; and,

WHEREAS, the Brownfield Redevelopment Authority (the "Authority") of the County of Shiawassee, pursuant to and in accordance with the provisions of the Brownfield Redevelopment Financing Act, being Act 381 of the Public Acts of the State of Michigan of 1996, as amended (the "Act"), has received and recommended for approval by the Shiawassee County Board of Directors, a Brownfield Plan (the "Plan") pursuant to and in accordance with Section 13 of the Act; and

WHEREAS, the Village of Lennon reviewed the Plan at their regular City Council meeting on July 14, 2025, and passed a Resolution of Concurrence and Resolution of Understanding to allow for the County of Shiawassee and Shiawassee County Brownfield Redevelopment Authority to administer the Plan; and

WHEREAS, the Township of Venice reviewed the Plan at their regular City Council meeting on June 2, 2025 and passed a Resolution of Concurrence and Resolution of Understanding to allow for the County of Shiawassee and Shiawassee County Brownfield Redevelopment Authority to administer the Plan; and

WHEREAS, the Authority has, at least ten (10) days before the meeting of the Shiawassee County Board of Commissioners at which this resolution has been considered, provided notice to and fully informed all taxing jurisdictions (the "Taxing Jurisdictions") which are affected by the Plan about the fiscal and economic implications of the proposed Plan, and the Shiawassee County Board of Commissioners has previously provided to the Taxing Jurisdictions a reasonable opportunity to express their views and recommendations regarding the Financing Plan and in accordance with Sections 13(13) and 14(1) of the Act; and

WHEREAS, the Shiawassee County Board of Commissioners has made the following determinations and findings:

- A. The Plan constitutes a public purpose under the Act;
- B. The Plan meets all of the requirements for a Brownfield Plan set forth in Section 13 of the Act;
- C. The proposed method of financing the costs of the eligible activities, as described in the Plan, is feasible and the Authority has the ability to arrange the financing;
- D. The costs of the eligible activities proposed in the Plan are reasonable and necessary to carry out the purposes of the Act;
- E. The amount of captured taxable value estimated to result from the adoption of the Plan is reasonable; and

WHEREAS, as a result of its review of the Plan and upon consideration of the views and recommendations of the Taxing Jurisdictions, the Shiawassee County Board of Commissioners desires to proceed with approval of the Plan.

NOW, THEREFORE, BE IT RESOLVED THAT:

1. Plan Approved. Pursuant to the authority vested in the Board by the Act, and pursuant to and in accordance with the provision so Section 14 of the Act, the Plan is hereby approved in the form attached as Exhibit "A" to this resolution. The Brownfield Plan for the Lennon Road Redevelopment project, as presented pursuant to and in accordance with the provisions of Act 381 of the public acts of the State of Michigan of 1996, as amended. The duration of the plan is

estimated for a twenty-five (25) year period but shall not exceed thirty-five (35) years as provided by subsequent increases or decreases in the Tax Increment Revenues per Act 381.

2. Severability. Should any section, clause, or phrase of this Resolution be declared by the Courts to be invalid, the same shall not affect the validity of this Resolution as a whole nor any part thereof other than the part so declared to be invalid.
3. Repeals. All resolutions or parts of resolutions in conflict with any of the provisions of this Resolution are hereby repealed:

AUTHORIZING RESOLUTION FOR MICHIGAN COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) FUNDING

At a regular meeting of the Board of Commissioners of Shiawassee County, held on July the 16th 2025, at the Surbeck Building located at 201 N. Shiawassee St Corunna MI, the following resolution was offered:

WHEREAS, the County desires to establish the "Creek Pointe Project" to support residential and/or mixed-use development through necessary infrastructure improvements, and to pursue funding opportunities to facilitate such improvements; and

WHEREAS, Shiawassee County intends to apply to Michigan State Housing Development Authority (MSHDA) for \$619,500 in funding assistance through the Community Development Block Grant (CDBG) Program, and is committed to providing local matching funds in the amount of \$0 from Shiawassee County; and

WHEREAS, the proposed Project is consistent with the community development plan adopted by the Shiawassee County, as described in the application to be submitted to MSHDA and no citizens will likely be displaced by these activities; and

WHEREAS, all proposed activities will be undertaken for the primary purpose of providing infrastructure to create permanent residential structures that, upon completion, will be occupied by 51% low- and moderate-income households; and

WHEREAS, no costs, whether funded by CDBG or non-CDBG sources, will be incurred prior to a formal grant award, completion of environmental review procedures, and the receipt of written authorization to incur costs from the designated CDBG Specialist; and

NOW, THEREFORE, BE IT RESOLVED:

1. That Shiawassee County authorizes the submission of an application for CDBG funding for the Project described above;

AUTHORIZING ENTRY OF PARTICIPATION AGREEMENTS IN PARTIAL SETTLEMENT OF THE NATIONAL
PRESCRIPTION OPIATE LITIGATION

WHEREAS, SHIAWASSEE COUNTY filed a lawsuit to address the public nuisance that is the Opioid Epidemic;

AND WHEREAS Sandoz, Inc. ("Sandoz") has negotiated a proposed settlement agreement ("Proposed Settlement") with Participating Subdivisions and Participating Tribes;

AND WHEREAS the Proposed Settlement contains an agreement for Sandoz to establish a \$99,500,000 settlement fund to resolve pending opioid-related litigation;

AND WHEREAS SHIAWASSEE COUNTY previously executed Participation Agreements for the Distributor and Janssen Settlements, as well as the Teva, Allergan, CVS, Walmart, Walgreens, and Kroger Settlements, which have conferred and continue to confer valuable benefits;

NOW THEREFORE, SHIAWASSEE COUNTY authorizes the execution of a Participation Agreement for the Sandoz Settlement Agreement for a settlement amount of approximately \$158,199.88. A specimen copy of the material terms of the participation agreement is attached as Exhibit A to this resolution.
