

At the regular meeting of the Shiawassee County Board of Commissioners held on Wednesday, December 10, 2025 in the Commissioner Chambers, Surbeck Building, Corunna, Michigan:

The meeting was called to order by Chairman Brodeur at 5:00 p.m.

Pledge of Allegiance was recited.

Invocation was offered by Commissioner Haley.

Roll call found Commissioners Josh Haley, Gary Holzhausen, Bill Johnson, Cindy Garber, Brad Howard, Matthew Shepard and Chairman Gregory Brodeur present.

It was moved by Commissioner Garber, seconded by Commissioner Howard to approve the agenda as presented. Motion carried.

It was moved by Commissioner Garber, seconded by Commissioner Haley to approve the minutes of the November 19, 2025 Board of Commissioners meeting. Motion carried.

RESOLUTION #25-12-21

RESOLUTION OF CENSURE OF COMMISSIONER MATTHEW SHEPARD AT ITS REGULAR MEETING, DECEMBER 10, 2025 SURBECK BUILDING, CORUNNA, MICHIGAN 5:00PM

WHEREAS, Matthew Shepard has been a Commissioner for District 7 since January 2025;
and

WHEREAS, Commissioner Shepard recently sought five thousand dollars in financial assistance from Veteran Affairs for repairs to his vehicle; and

WHEREAS, Commissioner Shepard was required to fully disclose his financial assets, income

and liabilities in connection with his application; and
WHEREAS, Commissioner Shepard failed to disclose his salary as a County Commissioner on his application rendering the application for benefits materially misleading; and
WHEREAS, Commissioner Shepard's application was denied due in part to the misleading nature of his financial disclosures; and
WHEREAS, Commissioner Shepard became irate after the Veteran Board denied his application for benefits; and
WHEREAS, Commissioner Shepard attempted to use his status as County Commissioner to influence Veteran Affairs staff during discussions about the denial of his application; and
WHEREAS, Commissioner Shepard returned to the Veteran Affairs department the next day to further accost County staff about the denial of his application; and
WHEREAS, Commissioner Shepard admitted that he did not disclose his Commissioner salary on the application and tried to blame County staff for his failure; and
WHEREAS, Commissioner Shepard was argumentative and began using foul language in the presence of County employees causing concern for their safety; and
WHEREAS, Commissioner Shepard treated a female County employee in a disrespectful manner by trying to order her out of his presence; and
WHEREAS, County employees deserve to be treated with dignity and respect instead of contempt and scorn; and
WHEREAS, Commissioner Shepard's behavior amounts to a corrupt attempt to trade upon his elected office for personal financial benefit; and
WHEREAS, this is not the first time that Commissioner Shepard's behavior has negatively impacted County employees; and
WHEREAS, it is determined that Commissioner Shepard acted in a dishonest, unethical and inappropriate manner throughout the course of this episode; and
WHEREAS, Commissioner Shepard's conduct is particularly disturbing given that he frequently makes baseless allegations of corruption against other officials; and
WHEREAS, the Board of Commissioners must hold its members accountable for actions that bring disrepute upon the County and the Board of Commissioners.
THEREFORE, BE IT RESOLVED, that the Shiawassee County Board of Commissioners declares that Commissioner Matthew Shepard is censured for his conduct set forth above.
BE IT FURTHER RESOLVED, that the Board of Commissioners will monitor Commissioner Shepard's behavior closely and take any further action necessary to protect County employees from harassing and abusive behavior by Commissioner Shepard.

RESOLUTION #25-12-19
FISCAL YEAR 2026 ANNUAL BUDGET

WHEREAS the Uniform Budgeting and Accounting Act, Public Act 2 of 1968, as amended, requires each local unit of government to adopt a balanced budget for all required funds;

WHEREAS the Finance and Administration Committee of the Board of Commissioners has reviewed requests for funding and recommendations on anticipated revenues from the county's elected officials, department heads, agency directors, and other staff; and

WHEREAS the Shiawassee County Board of Commissioners will duly advertise and conduct a public hearing on December 10, 2025 for the 2026 proposed budget in accordance with the Uniform Budgeting and Accounting Act:

NOW THEREFORE BE IT RESOLVED that the Board of Commissioners of Shiawassee County, Michigan, does hereby approve and adopt the FY 2026 general fund budget, projecting revenues totaling **\$23,314,686** and expenditures totaling **\$23,314,686** based on an approved millage of **5.3597 mills** (after Headlee reduction);

BE IT FURTHER RESOLVED that pursuant to MCL 46.71, all claims (bills) against Shiawassee County shall be approved by the Board of Commissioners prior to being paid, except that the Administrator's office may, in the ordinary course of business, pay pending budgeted payroll and certain other claims prior to approval by the Board if necessary to avoid late penalties, service charges, interest, or adverse legal consequence. The Board shall receive a list of claims paid prior to Board authorization for approval at the next Board meeting;

BE IT FURTHER RESOLVED, that the Board of Commissioners approves a hiring freeze on all positions. The Board of Commissioners does require that any vacancy in existing positions be reviewed by the Finance and Administration Committee and approved by the Full Board prior to being refilled.

BE IT FURTHER RESOLVED that the Board of Commissioners hereby approves and adopts the FY 2026 budget for Special Revenue Funds;

BE IT FURTHER RESOLVED that the Administrator shall serve as chief fiscal officer and chief administrative officer for the purposes of the Uniform Budget and Accounting Act, PA 1968, as amended (MCL 141.421 et seq.);

BE IT FURTHER RESOLVED that the Administrator's office shall be authorized to make budget amendments transferring up to \$6,000 between accounts, departments, or funds without prior approval from the Board; and

BE IT FURTHER RESOLVED that whenever it appears to the Administrator's office that the actual and probable revenues will be less than the estimated revenues upon which appropriations were based, or when it appears that expenditures will exceed an appropriation, the Administrator's office shall present to the Board recommendations to prevent expenditures from exceeding available revenues or appropriations for the fiscal year. Such recommendations shall include proposals for reducing appropriations, increasing revenues, or both.
