35th CIRCUIT COURT, LOCAL ADMINISTRATIVE ORDER 2025-2

EXTREME RISK PROTECTION ORDER

In accordance with MCR 3.718(B)(3), the court establishes this Plan of Judicial Availability to make a judge on duty and available each day of the year to immediately review and rule on a verbal request, made by a law enforcement officer, for an immediate emergency ex parte extreme risk protection order under MCR 3.718(B). This plan, once approved by the State Court Administrator, must be provided to all law enforcement agencies within this court's jurisdiction.

Extreme Risk Protection Immediate Emergency Ex Parte Availability Plan

IT IS ORDERED:

1. Judge Stewart, Circuit Court Judge will be assigned to ERPO cases including immediate emergency requests.
2. In the event that Judge Stewart is unavailable, Judge McKone will be assigned to ERPO cases including immediate emergency requests. If Judge McKone is assigned, this will be communicated to Central Dispatch and the 35th Circuit Court Clerk's Office via email.
3. All immediate emergency ERPO requests by law enforcement officers during normal business hours shall be made by calling the Circuit Court Clerk's Office at 989-743-2262 option 3. The Clerk's Office shall immediately contact the ERPO Compliance Officer or their designee.
4. After hours requests shall be made by calling Central Dispatch at 989-743-9111. Central dispatch shall immediately contact Judge Stewart and in his absence Judge McKone.

5. ERPO information will be placed on the Court's website.
